Dear Mr López Aguilar,

Thank you for your letter of 23 July 2012 in which you express the interest of your Committee in the mid-term review by the European Commission of the implementation of the Stockholm Programme.

The European Commission is committed to build the Union's area of freedom, security and justice along the renewed institutional and policy framework given by the Treaty of Lisbon. The Stockholm Programme of December 2009, as much as the European Parliament resolution of 25 November 2009 have defined strategic guidelines for our legislative and operational planning within the area of freedom, security and justice.

The European Commission has been active in proposing the individual measures, as have been the European Parliament and the Council in examining them.

Indeed, since I took office as the EU's first Justice Commissioner, I have presented a considerable number of policy initiatives, legislative proposals and political reports related to the goals of the Stockholm programme and your resolution. I attach to this letter a comprehensive list of these actions. As you will see and thanks in large part to your constructive support, several of the proposals have already become, or are about to become, EU law.

In the remaining years of the mandate of this Commission and this European Parliament, I intend to present further proposals towards delivering a true freedom, security and justice area to our citizens.
